Suitable for use on both sealed and un-sealed, polished and unpolished surfaces.

#### Directions for use

For application and cleaning tools see LTP website

Dilute 2 or 3 capfuls (5 capfuls on dirtier floors) in a bucket of warm water. Wash the floor and allow to dry. Does not require rinsing.

#### Coverage

1 litre of LTP Porcelain Floor Tile Cleaner should be sufficient to wash an average floor of 20m<sup>2</sup> approximately 40 times.

#### Notes

**Important:** Polished surfaces & highly glazed tiles finish by buffing with a dry soft cloth or machine.

**Contains** 5% or over but less than 15% anionic surfactant. 5% or over but less than 15% non-ionic surfactant.
