LTP MOULDEX PAVING CLEANER

Kills & removes mould spores, black spot, lichen, fungus & algae from all types of external natural and artificial stone including concrete pavers.

Antibacterial action helps prevent re-growth.

Formulated to cling to surfaces and remove mould spores, black spot, lichen, fungus, algae and moss from other damp places. Bleaching action helps restore natural stone and paving to its original colour.

Directions for use

For application and cleaning tools see LTP website.

SHAKE WELL BEFORE USE. This product contains bleaching action. Test on an inconspicuous area before general application. Surfaces to be treated should be completely dry.

Mould, Fungus and Algae: Pour solution directly onto the pavers and spread out evenly using a sponge or paint brush. Leave for a minimum of 1 hour. Apply a little water and agitate with a stiff Deck brush or black emulsifying pad to release residues of mould, fungus and algae from the surface. Rinse thoroughly using a hose or jet wash. Some stubborn stains and black spot may require a longer treatment,.

Black Spot, Lichen and Moss: Pour solution directly onto the pavers and spread out evenly using a sponge or paint brush. Cover with plastic sheeting or tarpaulin and leave overnight. After uncovering, add a little water and gently agitate using a medium brass coated wire brush. Rinse thoroughly using a hose or jet wash. Heavily contaminated surfaces may require more than one application. If small traces of black spot still remain after treatment, it should gradually fade and disappear within a few days following the treatment. If not: re-apply.

NB: Keep pets away during treatment. In case of contact with metals, fabrics and painted surfaces rinse with water immediately. Do not use on warm surfaces. Do not apply if rain is imminent. Avoid contact with plant life: if contact is made rinse well with plenty of water.

Do not use with acid based removers or other acid based cleaners.

Further Treatment: Sealing newly cleaned surfaces with LTP External Stone Sealer will help prevent moisture and organic particles from absorbing into the surface, reducing the growth of algae and black spot.

5-15 m2 per litre depending on the extent of soiling.

Shelf life: Once opened use within 6 months of purchase for optimum results.
